ORDINANCE NO. 2020-6

AN ORDINANCE SETTING A PROPERTY TAX RATE FOR THE TOWN OF SAN FELIPE, TEXAS, FOR TAX YEAR 2020 AT \$0.12694 PER \$100.00 DOLLAR VALUATION.

WHEREAS, the Town Council of the Town of San Felipe, Texas notified residents and property owners of the Town of San Felipe of its proposed tax rate as required by law; and

WHEREAS, the Town Council of the Town of San Felipe. Texas has determined that the tax rate for the Town of San Felipe for Tax Year 2020 should be the voter approval tax rate: and

WHEREAS, the Town Council of the Town of San Felipe, Texas shall set the property tax rate for the Town of San Felipe through the adoption of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SAN FELIPE, TEXAS, THAT:

Section 1. There be and is hereby levied and shall be assessed and collected for the year 2020, on all taxable property, real, personal and mixed, situated within the city limits of the Town of San Felipe, Texas, and not exempt the Constitution of the State and valid state laws, an ad valorem tax rate of \$0.12694 on each One Hundred Dollars (\$100.00) assessed value of taxable property, and shall be apportioned and distributed as follows:

- (a) For the purpose of defraying the current expenses and budget of the municipal government of the Town of San Felipe (maintenance and operations (M&O)), a tax rate of \$0.12694 on each One Hundred Dollars (\$100.00) assessed value of taxable property.
- (b) For the purpose of creating a sinking fund to pay interest and principal maturities on all outstanding debt of the Town of San Felipe, not otherwise provided for, a tax rate of \$0.00 on each one hundred dollars (\$100.00) of assessed value of taxable property within the Town San Felipe which shall be applied to the payment of interest and maturities of all such outstanding debt.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.19% AND WILL LOWER TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100.000.00 HOME BY APPROXIMATELY \$12.81.

Section 2. The Town Secretary shall cause the following notice to be posted on the homepage of the Town's internet website:

THE TOWN OF SAN FELIPE, TEXAS, ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.19% AND WILL LOWER TAXES FOR MAINTENANCE AND OPERATIONS ON

A \$100,00.00 HOME BY APPROXIMATELY \$12.81.

Section 3. All taxes levied by virtue of this Ordinance shall be due and payable on October 1, 2020 and shall become delinquent after the 31st day of January 2021. If any person fails to pay ad valorem taxes on or before the 31st day of January 2021, the penalties and interest set forth under Section 33.01 of the Texas Tax Code shall apply.

Section 4. The Austin County Tax Assessor-Collector is hereby authorized to assess and collect the taxes of the Town of San Felipe. Texas, employing the above stated tax rate.

Section 5. All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of said conflict.

ORDINANCE NO. 2020- 7

AN ORDINANCE ADOPTING A HOMESTEAD EXEMPTION FOR RESIDENTS OF THE TOWN OF SAN FELIPE, TEXAS, WHO ARE DISABLED OR OVER 65 YEARS OF AGE AS ALLOWED UNDER TEXAS TAX CODE, CHAPTER 11.

WHEREAS, the Town of San Felipe has previously instituted a tax exemption for residents of the Town of San Felipe who are disabled or over 65 years of age; and

WHEREAS, the Town Council of the Town of San Felipe has determined that it is in the best interest of the citizens of the Town of San Felipe to provide a homestead exemption for residents of the Town of San Felipe who are disabled or over 65 years of age; and

WHEREAS, the Austin County Appraisal District has appraised the taxable value of properties and will need a determination of tax exemptions that have been approved for the Town of San Felipe as soon as possible.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF SAN FELIPE, THAT:

Section 1. In accordance with Texas Tax Code section 11.13(d)-(e), the Town Council of the Town of San Felipe hereby approves a tax exemption of \$5,000.00 for Fiscal Year 2020-2021 for individuals who are disabled.

Section 2. In accordance with Texas Tax Code section 11.13(d)-(e), the Town Council of the Town of San Felipe hereby approves a tax exemption of \$5,000.00 for Fiscal Year 2020-2021 for individuals who are over 65 years of age.

Section 3. The Town Council of the Town of San Felipe hereby authorizes the Mayor to forward this Ordinance to the Austin County Appraisal District upon its passage.
